District Councillor Peter Neatherway reported that the works for the Bus Stop on the Mundesley Road were nearly complete; he had arranged for a space for a bin next to the bus shelter. The Clerk would look into the cost of a bin in this location and also the possibility of a Grit Bin

The Council offered their thanks to Peter and also to Ed Maxfield for their help in getting the bus stop moved and installed

A Parishioner reported that the dog bins had not been emptied - The Clerk would report this issue

There were reports that the footpath at Green lane was overgrown and there was a sign on site that asked people to use it or loose it - The Clerk would report this to the County Council

Children were reported to be climbing over the fence at the pond - Danger Deep water signs may be installed in the future

The waiting point for the North Walsham Bus, near Knapton Green was overgrown - The Council would look into this

The Overgrown Hedge near the entrance to the Parish Land will be cut back by Highways The current gate on the entrance to the Parish Land needs replacing - Clerk to look into costings

A question was raised about pedestrian access onto MADRA land near to their car park entrance, the Parish Council have raised this with MADRA as it is felt that access to the bottle banks is a problem when the main gates are locked

The question of CCTV was raised, the council felt that they had no way of powering CCTV or anywhere onsite to put the system to run it. The Council agreed to speak to MADRA to see if this is something they have plans for in the future
