The Council agreed to apply for the grant for a replacement bus shelter at Wilds Way

g. To consider and agree granting permission for UK Power Networks to cut back the trees near the Anglian Water entrance to the Playing Field

The Council agreed for the tree works to be carried out on the Playing Field

The Council agreed to measure up the area and get quotes for fencing off some of the area

Email regarding the Lease of the Playing Field - The Council discussed this matter and, once the paperwork had been collected from the solicitor, arrange an appointment to discuss the matter further with the sender of the email

Cllr Neatherway, North Norfolk District Council gave his report, he discussed the latest developments regarding devolution and spoke about the upcoming Environment Day to be held in Trunch

CNC Police reported that the transition from MOD Police to CNC Police had gone well and that they are still working closely with Norfolk Police, the area they cover had been increased and now includes Trunch and Mundesley

A parishioner asked if, in light of the recent antisocial behaviour at MADRA, if the council's risk assessment for the playground had included the problems - The Clerk would look into this and report at the next meeting

It had been reported that MADRA have installed CCTV Cameras on site - as this was not a parish council matter the resident was requested to speak to MADRA

A reaction to a post on Facebook regarding the vandalism at MADRA was queried, the clerk would make arrangements for the admin on facebook to be updated

A problem with the trees on School Close was bought to the attention of the Council, the clerk would write to Flagship regarding this matter

A discussion regarding the playground was raised and it was asked why Knapton could not have a Skate Park or pump track, this would be considered under the plans for the playground
