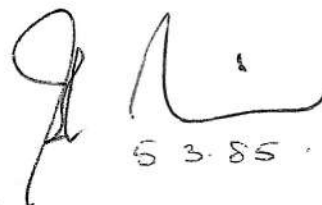

Notes of an informal meeting at Knapton Old Hall 18.06 01

Present A. Cargill, Reps. KPC. J.Lambert, C.Venvell, HJ. Wild, D.Spencer (KPC MADRA rep,)

Knapton Parish Council as joint lessors of land at Knapton with A.Cargill, on which the MADRA Club is situated has requested this meeting to discuss recent concerns regarding the club.

1. General maintenance and presentation of the grounds and premises:
 - a) broken fencing and chains at entrance
 - b) rubbish and discarded goal posts around field
 - c) lack of regular maintenance of hedges and field
2. Safety
 - a) state of huts and metal storage container
 - b) discarded refrigerator at rear of premises
 - c) condition of refuse disposal area and surroundings
- 3.Children's Playground:
 - a) quality of surfaces, particularly beneath swings.
 - b) broken slide
 - d) unpainted and generally unkempt equipment
 - e) health and safety checks not being carried out
 - f) the grass on the play area is unacceptably overgrown
- 4.Sub-letting contrary to terms of lease:
 - a) caravans on KPC field (fear of encouraging unauthorised "Travellers")
The lease states that the Villagers should have freedom of access at any time. Caravanners also bring dogs which are a health hazard on playing fields and the presence of dogs is forbidden in the lease.
 - b) parking of motor vehicles is also not allowed for the reasons stated above.
3. Access: Village children have been warned off and have been verbally abused by club members. They should have access to the Knapton part of the site.
4. Communication: Despite a member of the KPC having a presence and a vote at MADRA Committee meetings it is often impossible to obtain a response or reply to the Parish Council's concerns.

It was generally agreed that there were major concerns regarding the problems of MADRA. However, since a new committee is now in place it was decided that David Spencer as KPC's representative should, in the first instance, attempt to approach the club Chairperson to voice these concerns with a view to solving the more urgent problems.

1. The meeting was opened by the acting Chairman Mr. Alan Young at 7:45pm (the meeting started later than anticipated as names of volunteers wishing to stand as Trustees were being obtained).
2. ADOPTION OF MINUTES
The minutes of the previous AGM were proposed by S. Ruffett and Seconded by S. Studd. Minutes adopted as a true record by those present.
3. MATTERS ARISING from previous minutes –None
4. ACTING CHAIRMAN'S REPORT:
 - a) Following the events of recent weeks, it was agreed that the meeting would be opened by Alan Young (Chairman of Knapton Parish Council). He explained to the floor that changes must be made to the way MADRA is run to meet the rules of the Charities Committee. MADRA was set up as a Charity, it's objective being to provide sports and recreational facilities for seven villages as listed in the original documentation. It should have a separate Fundraising Committee, and a separate Bar and Social Committee. During the 25 years MADRA has been in existence, we have gradually strayed from this primary objective and the set-up of the club no longer meets Charity Commission's rules which are set down in the Legal Document. MADRA should seek to reinstate its charitable aims by separating the Recreation Facilities from the Bar and Social Club. A separate entity, with a different name, should be set up to run the social side, the bar. This should have a separate management committee and separate bank account. Any profit from this can then be legally paid free of tax to MADRA at year end. Any social or trading activities undertaken by the Association, other than those undertaken only in connection with participation in healthy recreation, would not fall within the charitable purpose of promoting community participation in healthy recreation. Activities of this kind, which include running a bar for instance, would have to be carried out by a separate non-charitable body such as a social club. What is required is that the activities are carried on at arm's length from the charity. What is important is that the two activities, especially the financial and administrative arrangements, are kept separate.

Go-ahead for sports centre at Knapton

AFTER a six-year struggle to establish a sports centre, Mundesley and District Recreation Association (MADRA) has been given the go ahead.

At a meeting at the Coronation Hall, chaired by Mrs. June Britton, villagers voted overwhelmingly in favour of establishing the centre at Knapton and using £7500 already raised to purchase land.

After Mr. Roy Haines had

outlined the history of the association's search for a suitable site in the district, Dr. John Miller put forward the Knapton proposal.

The centre would be created next to the now disused Knapton school and would embrace two existing areas, the present sports field behind the school and adjoining fields amounting to an additional 4.3 acres.

The present sports field belongs to Knapton village and a provisional lease of 28 years has been agreed. It consists of two acres on which there is a full-size football pitch and an

entrance way which includes Knapton's children's playing area. This would be retained under the scheme.

The additional 4.3 acres belongs to Mr. Adam Cargill and he is willing to release the land. This would allow for a cricket table, another full-sized soccer pitch (or hockey or rugby pitches), adequate car parking and the provision of a pavilion.

A 10-metre belt of trees and other vegetation would screen the area which was ideally suited for the purpose said Mr. Hart, of the Norfolk Playing Fields Association, who had assisted in the search.

Both he and a representative of the North Norfolk District Council expressed broad agreement in principle with the scheme and felt that grants could be forthcoming from various sources.

After completion of the Knapton centre, which is located off the Mundesley-North Walsham road, the association envisages improving the children's play area in Gold Park, Mundesley, and possibly establishing some tennis courts on the sea front.

With the well-equipped theatre-cum-meeting place, the Coronation Hall, already established and new bowling greens in the High Street, this would give Mundesley and district a comprehensive range of sport and leisure facilities.
