

Minutes of the meeting of Knapton Parish Council held on the 5th March 2024 at 7:30pm in Knapton Village Hall

The minutes of the meeting of Knapton Parish Council held on the 12th December 2023 were agreed and signed at the meeting

The Chair closed the meeting and invited members of the public to speak about issues in the community.

A member of the public asked why a Councillor had felt the need to make a comment about a possible Police Presence. Concerns were raised by residents about MADRA and the relationship between MADRA and the Parish Council. The issues highlighted were about noise, trespass, increased traffic on Hall Road and the MADRA lease. The discussion became heated and extremely un-pleasant, with accusations being made against members of the council and a member of the council behaving in an inappropriate manner. Cllr Winter left the meeting at 19.56 as a result of feeling intimidated.

Questions were also raised about the proposed play area at Wilds Way, the council is awaiting further contact from the landowner. The Chair also said that an Engagement Meeting was being organised by Victory Housing to be held on 15th May and all residents will receive their invitations from Victory in due course.

A further issue was raised about the passing place on Hall Lane where wooden posts had been installed. The Chair said that Highways would be asked to look into this.

The Chair asked for parishioners with concerns to write to the Clerk and any questions would be answered. There would also be a meeting arranged for the public to discuss the MADRA lease and the noise at MADRA would be monitored

Public participation time ceased at 20:32 and the meeting was re-opened.
