Minutes of a Meeting of Knapton Parish Council held on 6th June 2023 in Knapton Village Hall at 7.30pm

3) Clir Ed Maxfield: had sent his report. PN had nothing yet to report

4) Minutes of the Meetings held on 9th May:

Parish Council minutes were agreed and signed by the Chair, proposed JL seconded LW. Annual Village Meeting minutes were agreed and signed by the Chair, proposed JSH, seconded LW.

PN invited AY to speak. AY asked about the cost of grass cutting as the PC had approached the Fete Committee with a request for them to fund this. The grass had been cut by ALS very promptly following a request from PN. The PC would inform the Fete Committee of the cost when known. Suggestions were made that there may be someone willing to do the work on a regular basis for the cost of the fuel. JHS would ask someone from The Pines in The Street and from Trunch, and PN would approach Andrew Claydon. JHS would also put it on Facebook.

5) Matters Arising:

- a) Repair/replacement of slide. PN and JL would look at this again. AY would also look at it.
- b) New dog waste bin had arrived. David Jackson had agreed to install it and DH would advise of exact position.

6) Parish Councillors Reports:

- a) JSH reported an overgrown footpath. These were being cut.
- b) LW had so far received £1,500 from the Gas Site companies. One more contribution awaited.

7) Planning Application IB/23/1121: erection three poles in Knapton by County Broadband:

This application was advisory and PS would find out more from NNDC. County Broadband were installing fast fibre in some properties. There was concern about the positioning of the poles. None would be on private land.
